In case of hand delivery sealed envelope bearing above reference number, containing quotation on duly signed printed letterhead of the vendor, must be submitted along with the proof of remittance of EMD to the inward clerk of the institute who will acknowledge the receipt of the same. At the time of receiving the purchase order this acknowledgement must be produced by the vendor to whom the PO is placed.

In case vendor fails to remit the necessary amount of EMD and supply the scanned/printed copy of such remittance the bid shall stand rejected.

- G. Security Deposit – On allotment of work the security deposit equal to 10% of quoted price has to be paid. EMD of vendor whom work shall be allotted shall be converted into security deposit and the balance amount of security deposit shall be recovered from the bills payable. Security deposit shall be refunded after a period of 91 days termed as defect liability period. If any problems are noticed/faced by our network administrator in the firewall then the expenses, to make good the same, shall be recovered from the security deposit and the defect liability period shall be extended by another 91 days further. If in the extended defect liability period again such problems are noticed then the balance amount of security deposit shall be forfeited. If the expense incurred for repairs exceeds the balance security deposit amount, then in addition to blacklisting the vendor and publishing blacklisted vendor on our website the institute, at its discretion, may resort to legal proceedings to recover the said amount along

with damages. In the first defect liability period if the amount to be spent on repairs exceeds the security deposit then in addition to blacklisting the vendor and publishing blacklisted vendor on our website the institute, at its discretion, may resort to legal proceedings to recover the said amount along with damages.
