Policy Document on Green campus, Environment issues & Energy usage for Kegaon Solapur Campus

In view of maintaining pollution free green campus, conducive environment in the campus and to minimize the energy usage of the campus all the members including students (day scholars and hostellers), teaching and non-teaching staff and the families staying in the campus, different vendors such as owners of mess, canteen, general stores and other facilitators are informed to adhere the following guidelines:

1. As to maintain the cleanliness and greenery in the campus and to make it as plastic free campus everyone is required to take care of following points:

a) Do not throw the garbage, plastic wrappers and bottles anywhere in the campus instead put them in the dustbins placed at various places.

b) Do not spit, chew tobacco and smoke inside the campus as it is strictly prohibited in the campus.

c) Do not touch to any of the tree/plant and maintain sufficient distance from them.

d) Management has taken good efforts to increase the vegetation inside the campus in spite of shortage of water. Therefore, always respect these initiatives.

e) Do not ride the vehicles with overspeed and maintain the diversions and follow the traffic rules in the campus.

f) It is also mentioned here that large scale plantation/gardening work is in progress in the campus. Please communicate to all not to damage plants/sapling.

2. As water is essential but limited resource and since Solapur is drought prone region the water scarcity is increasing day by day and also to inform you that the institute is paying very exorbitant amount for making availability of water. Hence, it is obligatory for all of us to use water very judiciously. Therefore, following points need to be taken care:

a) Close the water taps after the use.

b) Do not flush the tanks if it is not required to do so.

c) Inform to the concerned staff regarding wastage/ leakage of water.

d) Maintain hygiene and cleanliness near the water taps.

e) Ensure all water taps are closed before leaving the office/room.

f) STP water will only be used for washing vehicles and watering to the trees. Drinking water will not be used at all for this purpose.

3. Since usage and conservation of electricity is also important in the national and societal interest, therefore, following points need to be taken care:

- a) Use electricity only when needed.
- b) Switch off fans & light before leaving the office/room.
- c) Avoid using corridor light during day time.
- d) As far as possible use natural light during day time since all room have adequate provision of natural light.
- e) All street light will be switch off at don (around first night) under the supervision of security supervisor/gunman on duty.
- f) Only one corridor light will be switched on in each building for security purpose at night.
- g) Neon light board will be switched off by midnight (12 PM)

4. It is recommended that appropriate instructions and awareness in this regard should be made amongst all the stakeholders associated with Kegaon Solapur campus.

5. Co-operation of all the stakeholders is highly solicited for this noble cause.
